## **Policy for Donor, Sponsor, and Partner Privacy**

*Effective: November 1, 2021*

### **Donor Consent and Rights**

As a donor or sponsor submitting personally identifying information to the Coalition Against Childhood Cancer (CAC2) or any CAC2 Board Members or staff through electronic, written, and/or oral communications, contributions, and event registrations, you consent to the terms and conditions of the Donor Privacy Policy and to CAC2's processing and use of personal information for the purposes stated below.

CAC2 respects our donors' and sponsors' choices and control over their information. All donors and sponsors have the right to review information that CAC2 has collected and stored. To review that information, please contact Steven L. Pessagno, CAC2 Treasurer, in writing using the contact information at the end of this document. All donors and sponsors also have the right to give anonymously, and, when CAC2 is notified of this intention, such donors and sponsors will not be publicly recognized or listed on online or offline recognition platforms.

### **Policy**

CAC2 collects and stores donor name, address, phone number, fax number, email address, and spouse/partner name as provided by the donor through CAC2's Website, at a special event, over the phone, by mailing a check, or through other contact and conversations with CAC2 Board Members or staff. From time to time, we may collect personal information from donors in ways not described above.

This information is used for the purposes of event registration, processing contributions, gift acknowledgement, donor recognition, solicitation, and relationship development between donor(s) and CAC2.

CAC2 will not sell, share, or trade our donors' names or personal information with any other entity, nor send mailings to our donors on behalf of other organizations.

CAC2 will collect payment information, billing address, and other information necessary to process a donation or event registration. To the extent any donations are processed through a third-party service provider, our donors' information will only be used for purposes necessary to process the donation.

CAC2 will use the personal information to protect against potential fraud. We may verify with third parties the information collected in the course of processing a gift, event registration, or other

donation. If a donor or sponsor uses a credit or debit card on the Website, CAC2 may use card authorization and fraud screening services to verify that your card information and address matches the information that you supplied to us and that the card being used is currently valid and has not been reported lost or stolen.

CAC2 will use donor and sponsor information to comply with the law or in the good faith belief that such action is necessary to conform to the requirements of law or comply with legal process served upon CAC2.

Except as described in this Privacy Policy or at the time CAC2 requests the information described herein, CAC2 does not otherwise disclose donor and sponsor personal information to any third parties.

This policy applies to all donor and sponsor information received by CAC2, both online and offline, on any platform, including, but not limited to, CAC2's Website and its mobile applications, as well as any electronic, written, or oral communications.

### **Policy Changes**

CAC2 reserves the right to change its Donor and Sponsor Privacy Policy and will note an effective date at the top of this Policy.
